



Only available in CAS system for OT programs. Number of individuals who averaged 3-4 applications each in 2022.








#### **OTA - % of Seats Filled**






#### **OTA - % of Seats Filled**






#### **Masters-% of Seats Filled**






#### **Doctoral-% Seats Filled**





























Trends in Medicare Part B therapy services from 2009-2021
